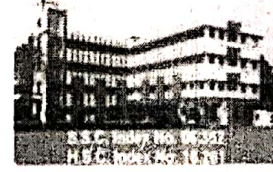

**2. Compensation:**

**3. Retirement:**

- a) The retirement age is 58 years.

**4. Responsibilities:**

- a) In view of your position and office, you must effectively, diligently and to the best of your ability perform all the task assigned to you and ensure results.

b) In case of withdrawal during the academic year, either party should give 3 months notice period or 3 months' salary in lieu of the notice period.

**10. On Separation:**

- a) On acceptance of separation notice, you shall ensure to handover all the materials of the organization in your possession that includes library books, presentation materials, data literature, drawings, and documents belonging to the organization. You shall not make or retain any copies of these items.


